Dorsey, Notary Public, Parish of Orleans State of Louisiana on December 4, 1969 and recorded in the records of the Secretary of State, by Amending the Articles of Incorporation in the following manner.

ARTICLE II IS AMENDED TO READ AS FOLLOWS:

The purpose for which the Corporation is organized is to engage exclusively in charitable, educational and scientific activities within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1954, as amended (or corresponding provisions of any subsequent federal income tax laws) and, more particularly and in furtherance of such activities, to seek, investigate, formulate, develop, organize and carry out programs and projects for improvement in housing and related facilities for low income families, particularly blacks, and for providing opportunities for members of minority groups, particularly blacks, to participate in organizing, financing, constructing, and managing such facilities, to rehabilitate existing and construct new low and moderate income housing and stimulate the construction of such housing by: (1) developing sources for construction financing and permanent financing; (2) investigating ways of securing performance bonds for contractors; (3) implementing innovative developments in the construction of housing; (4) developing procedures whereby families may construct and own their own homes; and (5) providing training for and otherwise encouraging members of low income and minority groups to become entrepreneurs, contractors, construction workers and managers in the housing field.
