## **NARRATIVE**

ON WEDNESDAY, MARCH 23, 2011 AT APPROXIMATELY 3:28PM OFFICER JOSEPH HEBERT UNIT 107B, RECEIVED A CALL VIA NOPD DISPATCHER TO INVESTIGATE A SIGNAL 35D, RELATIVE TO DOMESTIC ABUSE BATTERY AT 1401 FOUCHER (TOURO HOSPITAL).

UPON ARRIVAL, OFFICER HEBERT SPOKE WITH THE VICTIM, WITHOUT WAS ARRIVED THE FOLLOWING INFORMATION: ON THE ABOVE DATE AT ABOUT 10:30AM, HER EX BOYFRIEND, MR STEPHEN THOMAS ARRIVED AT HER RESIDENCE TO DISCUSS A MATTER ABOUT WORK. STATED THOMAS ASKED HER ABOUT A RUMOR THAT WAS GOING AROUND THEIR WORKPLACE ABOUT HIM HAVING SEXUAL INTERCOURSE WITH MALE INMATES AT CENTRAL LOCK UP. STATED SHE DID NOT WANT TO GET INVOLVED WITH IT IN FEAR OF GETTING IN TROUBLE AT WORK, IT WAS AT THIS TIME STATED THOMAS STRUCK HER WITH A CLOSED FIST IN THE FACE CAUSING HER TO FALL DOWN AND BREAK HER ANKLE.

OFFICER HEBERT OBSERVED ANKLE IN A CAST AND A SMALL CUT ON HER UPPER THIGH.

I.A.D. SPECIAL AGENT BYRON WOODS OF OPSCO ARRIVED ON SCENE TO CONDUCT HIS INVESTIGATION OF THE INCIDENT. WOODS STATED HE WOULD SUSPEND THOMAS FROM THE SHERIFFS DEPARTMENT, CONFISCATE HIS COMMISSION AND BADGE.

OFFICER HEBERT NOTIFIED SGT R YOUNG UNIT 130B, SGT K. TEMPLE UNIT 120B AND LT MONTEVERDE UNIT 110C OF THE INCIDENT.

OFFICER HEBERT RELOCATED TO CENTRAL LOCK UP AND MET WITH I.A.D. SPECIAL AGENT BYRON WOODS AS INSTRUCTED. WOODS STATED THEY WOULD WALK THOMAS OUT AND ALLOW HIM TO CHANGE CLOTHES. OFFICER HEBERT ADVISED THOMAS OF HIS RIGHTS PER MIRANDA, PLACED HIM IN DOUBLE LOCK HANDCUFFS AND RELOCATED HIM INSIDE CENTRAL LOCK UP ALONG WITH SPECIAL AGENT BYRON WOODS WHERE HE WAS BOOKED ACCORDINGLY.
