UPON ARRIVAL AT 9:00 PM, THE VICTIM, [REDACTED] STATED SHE WENT TO PICK HER TWO YEAR OLD SON, [REDACTED] 1704-07, FROM THE FATHER, STEPHEN THOMAS II AT MR THOMAS'S MOTHER'S RESIDENCE AT 14400 DWYER BLVD. ON 9-19-2009 AT 8:00 PM.

[REDACTED] STATED HER SON, RUYAL, WAS IN THE BACK SEAT OF AN UNKNOWN BLACK FEMALE ^{CAR} LICENSE PLATE # 545064, WITHOUT BEING SECURED IN A CAR SEAT. [REDACTED] STATED AN ARGUMENT STARTED

BETWEEN MR. THOMAS II AND HERSELF, WHEN THEY ENTERED MR. THOMAS'S MOTHER'S RESIDENCE. [REDACTED] STATED THE UNKNOWN BLACK FEMALE GOT INVOLVED IN THE ARGUMENT AND STRUCK [REDACTED] IN THE FACE AND ALSO STRUCK [REDACTED] IN THE HEAD WHILE MS.

[REDACTED] WAS HOLDING [REDACTED] IN HER ARMS. [REDACTED] STATED

THE UNKNOWN BLACK FEMALE WAS WEARING AN ORLEANS CRIMINAL SHERIFF DEPUTY UNIFORM AND [REDACTED] FATHER, MR. THOMAS II, IS ALSO EMPLOYED BY THE ORLEANS CRIMINAL SHERIFF DEPARTMENT AND WAS OUT OF UNIFORM. [REDACTED] STATED WHEN THE SCUFFLE

STOPPED BETWEEN HERSELF AND THE UNKNOWN BLACK FEMALE, SHE WENT OUTSIDE AND MR. THOMAS II FOLLOWED HER, PUT HIS HANDS AROUND ^{HER} NECK AND SQUEEZED. [REDACTED] STATED MR.

THOMAS II ALSO THREW HER TO THE GROUND. [REDACTED] TOLD
