Per your conversation with Rafael Goyeneche, I am providing you with the complaint history of Mark Andry.

The Metropolitan Crime Commission (MCC) has handled previous complaints involving alleged unprofessional conduct by Mr. Andry who serves as a Deputy Constable for the 2nd City Court. These complaints involved the alleged theft of property from people he was evicting.

On June 08, 2011, The MCC received a complaint from involving an alleged assault he witnessed at Algiers. The following day, the alleged victim of this assault, called our office to file a complaint regarding Mark Andry.

We contacted 2nd City Court Constable Ennis Grundmeyer regarding this latest incident and on June 14th Mr. Grundmeyer visited our offices. At that time we presented the Constable with written statements from both the victim and the witness to the June 7th incident. We questioned Constable Grundmeyer regarding the uniform Mr. Andry was wearing during the alleged assault. He informed us that Mr. Andry was also an Orleans Parish Sheriff's Office Deputy and only worked part time for the Constable.

After the meeting we received a letter dated June 21, 2011 from Constable Grundmeyer in which he notified us that Mr. Andry will be terminated effective July 1, 2011.

Dear Mr. Radosti:

On October 5, 2010, we met in my office to discuss a complaint filed with your office against my deputy, Mark Andry. At that time, we decided that I would speak with the deputy in question.

On October 6, 2010, I met with Deputy Andry and explained the context of our discussion to him. Additionally, I explained to him that, as a deputy constable, it is illegal for him or anyone else to remove any personal possessions from any eviction being legally executed by this office. Deputy Andry explained to me that he absolutely understood the law, additionally expressing that he thought this was one the major responsibilities of his position. He adamantly denied the allegations of the complaint and agreed to cooperate fully in the investigation.

As serious as the allegations of the complaint are, our investigation could not confirm any of the allegations. In consideration of the seriousness of the allegations, balanced with Deputy Andry's history of good service without complaints and the lack of proof for the complaint, I decided that the best course of action was to put Deputy Andry on a six-month probation period. That probationary period ends on April 7, 2011, at which time Deputy Andry will be reinstated to full working capacity, assuming that no other complaints are lodged and none of this complainant's allegations are proven true.

As stated above, my office could not verify any of the allegations of the complaint and Deputy Andry fully cooperated in the investigation. While I believe my actions were correct given those circumstances, if your office has additional information or if your office's investigation rendered other results, please let me know immediately so that I may reopen my investigation. My office will not tolerate any illegal activities from any of my deputies and issues such as this are of the utmost importance to me. Public trust is paramount in our job, which is often dangerous and unpopular even under the best of circumstances.
