NARRATIVE

ON SUNDAY, MARCH 6, 2011, AT ABOUT 9:38 PM, SGT. STUART SMITH OF THE 8TH DIST TASK FORCE B NOTIFIED THE CHANNEL 4 DISPATCHER THAT A LARGE SECOND LINE WAS HEADED INTO THE 5TH DISTRICT. SGT. SMITH REPORTED THE CROWD WAS THROWING BRICKS AND BOTTLES AT HIS OFFICERS AND POLICE UNITS. SGT. SMITH STATED THE CROWD WAS TRAVELING EASTBOUND ON CHARTRES STREET. THE CROWD HAD CROSSED THE ELYSIAN FIELDS CORRIDOR AND ENTERED INTO THE 5TH DIST. SGT. SMITH ALSO STATED ONE (1) SUBJECT WAS CARRYING A LIGHTED TORCH.

CHANNEL 4 DISPATCHED THE INFORMATION AND SGT GARY LACABE, UNIT 1580, OF THE 5TH DIST TASK FORCE "A" RESPONDED. SGT. LACABE ORDERED T/F "A" AND "B" TO RELOCATE TO ELYSIAN FIELDS AND CHARTRES TO ASSIST. SGT. LACABE ADVISED THE RESPONDING UNITS TO ADVISE THE BAND IF THEY DID NOT HAVE A PERMIT THAT THEY WOULD HAVE TO DISBAND THEIR ASSEMBLY. SGT. LACABE FURTHER ADVISED THE UNITS, IF THEY REFUSED; OFFICERS WOULD HAVE TO CONFISCATE THEIR INSTRUMENTS AND ISSUE SUMMONS OR ARREST THE SUBJECTS.

OFFICER CHAD COCKERHAM, UNIT 1585, STATED HE WAS ONE OF THE FIRST UNITS TO ARRIVE ON THE SCENE (2400 BLOCK OF CHARTRES STREET) AND MAKE CONTACT WITH THE BAND MEMBER. THE OTHER OFFICERS WERE LARRY DACE, UNIT 1583, MARCIA WATSON, UNIT 1587, ALL UNITS WERE OF THE 5TH DIST T/F "A". OFFICERS APPROACHED THE BAND AND SPOKE WITH BAND MEMBERS. THE BAND MEMBERS WERE ASKED DID THEY HAVE A PERMIT, AND IF NOT, THEY WOULD HAVE TO STOP PLAYING.

OFFICER COCKERHAM SPOKE WITH THE DRUMMER AND ASKED HIM TO COMPLY BY NOT PLAYING THE DRUM. THIS PARTICULAR DRUMMER STOPPED AT THAT TIME, BUT THE OTHER DRUMMERS CONTINUED TO PLAY AS IF THE POLICE WERE NOT PRESENT. THE BAND EXHIBITED TOTAL DISREGARD FOR THE LAW. THE VIOLENT CHAOTIC REVELERS MADE IT KNOWN THAT THEY REFUSED TO COMPLY WITH LAW ENFORCEMENT'S REQUEST. OFFICERS THEN OBSERVED AN INDIVIDUAL TURNING OVER THE CITIZEN'S OF THE NEIGHBORHOOD TRASH CANS, WHICH CREATED A DISTURBANCE. OFFICER MARCIA WATSON THEN NOTICE THE TIRE ON HER ASSIGNED POLICE UNIT, 511, WAS SLASHED. OFFICERS WERE MET WITH NEGATIVE HOSTILE AGGRESSION FROM THE CHAOTIC REVELERS OF THE UNAUTHORIZED PARADE. THE MASSIVE CROWD BEGAN TO SURROUND THE OFFICERS. OFFICERS REGRESSED FROM THE CHAOTIC REVELERS AND RETURNED TO THIER VEHICLES. SGT. LACABE WAS NOTIFIED.

OFFICER MARCIA WATSON STATED HER, OFFICERS LARRY DACE AND CHAD COCKERHAM ARRIVED ON THE SCENE AND OBSERVED A LARGE MASS OF PEOPLE WALKING IN A GROUP. OFFICERS OBSERVED THE SUBJECTS AS THEY KICKED CARS, STRUCK GARBAGE CANS, PLAYED MUSIC AND CARRIED LARGE ARTIFACTS. OFFICER WATSON ACTIVATED HER UNIT'S PA AND ANNOUNCED OVER THE SYSTEM THAT THE PARADE DID NOT HAVE A PERMIT AND NEEDED TO DISBAND AT ONCE. THE GROUP CONTINUED PLAYING AND BEHAVING IN A DRUNKEN AND ARROGANT MANNER.

OFFICERS WATSON, COCKERHAM AND DACE EXITED THEIR UNITS AND APPROACHED DIFFERENT UNRULY REVELERS. SOME INDIVIDUALS COMPLIED WITH OFFICERS' REQUEST OF ORDER AND SOME DID NOT. OFFICER WATSON RETURNED TO HER UNIT TO DISCOVER AN UNK. BEVERAGE HAD BEEN POURED OVER THE TOP OF HER UNIT AND THE REAR TIRE WAS SLASHED. OFFICER WATSON NOTIFIED THE DISPATCHER THAT HER TIRE WAS SLASHED BY AN INDIVIDUAL OF THE CROWD. THE UNAUTHORIZED PARADE CONTINUED ON ITS PATH FORWARD AS OFFICER WATSON BEGAN TO MOVE HER POLICE UNIT INTO THE DRIVEWAY OF 2420/22 CHARTRES ST.

AT THAT TIME OFFICER WATSON HEARD OFFICER ANANIE MITCHELL DISPATCH A 10-28 (FOOT PURSUIT) THEN 10-55 (OFFICER IN NEEDED OF ASSISTANCE). OFFICER WATSON STATED SHE ENTERED THE VEHICLE WITH OFFICER DACE AND OFFICER COCKERHAM AND RELOCATED TO CHARTRES AND FRANKLIN AVENUE. ON ARRIVAL OFFICER WATSON STATED SHE RELOCATED AN ASSISTED OFFICER MITCHELL WITH AN ARREST IN THE 2600 BLK. OF CHARTRES ST.

AS OFFICER MITCHELL ASSISTED THE ARRESTED SUBJECT TO HIS FEET, THE CROWD BEGAN CHANTING, "LET HIM GO!" OFFICER WATSON STATED SHE THEN OBSERVED OBJECTS FLYING OVER HER HEAD, BEING THROWN FROM THE SIDEWALK AREA. OFFICER WATSON STATED SHE COULD HEAR GLASS SHATTERING NEARBY AS AN OFFICER STATED," THEY'RE THROWING BOTTLES AT US RUN!" OFFICER WATSON INFORMED THE OTHER OFFICERS NOT TO RUN, BUT TO WALK, STAY TOGETHER. OFFICER WATSON REQUESTED ASSISTANCE IN MAINTAINING THE REAR FOR OFFICER SAFETY. OFFICER WATSON SUSTAINED INJURIES TO THE PALM OF BOTH OF HER HANDS DURING THE ARREST.

OFFICERS OF THE 5TH DIST TASK FORCE "B" WERE AT THE INTERSECTION OF CHARTRES ST. AND FRANKLIN AVE. UNITS 1596, OFFICERS TONY BURRELL AND JERMELL TAYLOR, 1594 OFFICERS CORBY SLAGLE AND TERRENCE DAVIS, 1593 QUALYNDREA JONES AND 1591 OFFICER LAWRENCE WEATHERSBY OBSERVED THE UNRULY VIOLENT CROWD AS THEY CONTINUED EASTBOUND ON CHARTRES ST.

OFFICER JOSEPH DAVIS, UNIT 1589, OBSERVED AN UNK. W/M PARTICIPANT WITH AN OBJECT; WHICH HE BELIEVED TO BE A KNIFE, IN HIS HAND. OFFICER DAVIS OBSERVED THE SUBJECT SLASH THE TIRES OF UNIT 531 WHICH WAS PARKED AT THE ABOVE LISTED LOCATION. OFFICER DAVIS ATTEMPTED TO MAKE AN APPREHENSION OF THE PERPETRATOR. THE PERPETRATOR FLED ON FOOT AND OFFICER DAVIS GAVE A BRIEF FOOT PURSUIT AS HE ORDERED THE SUBJECT TO STOP. OFFICER DAVIS PRODUCED HIS ELECTRONIC CONTROL DEVICE (E.C.D.) AND DEPLOYED. THE PRONGS OF THE DEVICE DID NOT MAKE CONTACT WITH THE SUBJECT. OFFICER DAVIS ORDERED THE SUBJECT TO STOP AND DROP THE KNIFE. THE SUBJECT STOPPED AND OFFICER DAVIS ARRESTED MICAH MARTIN (W/M, DOB CONTROL DEVICE DAVIS ADVISED THE SUBJECT OF HIS MIRANDA RIGHTS AND OBTAINED THE OBJECT HE BELIEVED TO BE A KNIFE. OFFICER DAVIS LEARNED THE OBJECT WAS A PAIR OF SCISSORS. THE SCISSORS WERE CONFISCATED AS EVIDENCE. OFFICER DAVIS ESCORTED MICAH MARTIN TO THE POLICE UNIT AND THE CROWD BEGAN TO EXPLODE.

AS OFFICER DAVIS ATTEMPTED TO PLACE MICAH MARTIN IN THE POLICE UNIT, AN UNK. W/M GRABBED MICAH MARTIN AND ATTEMPTED

TO PULL HIM AWAY FROM POLICE CUSTODY. THE UNRULY W/M REFUSED TO RELEASE MICAH MARTIN. OFFICERS ANANIE MITCHELL AND TONY BURRELL OBSERVED THIS INCIDENT AND WENT TO ASSIST. THE OFFICERS OBSERVED THE UNK. W/M AS HE FLED ON FOOT AFTER HE OBSERVED OFFICER MITCHELL AND BURRELL. THE OFFICERS ENGAGED IN A BRIEF CHASE OF THE SUSPECT. OFFICERS ADVISED THE SUSPECT TO STOP SEVERAL TIMES. OFFICER MITCHELL ADVISED THE SUSPECT TO STOP ARE HE WOULD BE TASED. THE SUSPECT FAILED TO COMPLY WITH THE OFFICER'S COMMAND. OFFICER MITCHELL TASED THE SUSPECT AND THE UNK W/M FELL TO THE GROUND. OFFICER MITCHELL AND BURRELL ATTEMPTED TO HANDCUFF THE SUSPECT, BUT THE SUSPECT CONTINUED TO RESIST. OFFICER MITCHELL THEN PERFORMED A DRIVE STUN ON THE SUSPECT AND THE SUSPECT THEN COMPLIED WITH THE OFFICER'S COMMAND. OFFICER MITCHELL WAS ABLE TO HANDCUFF THE SUSPECT. OFFICER MITCHELL ADVISED THE SUSPECT, DAMIEN WEAVER (W/M, DOB

AFTER THE ARREST, OFFICER ANANIE MITCHELL HAD SERIOUS COMPLICATION WITH HIS RIGHT KNEE. THE OFFICER DISCOVERED HIS KNEE SUSTAINED AN INJURY. OFFICER MITCHELL LATER RELOCATED TO TULANE MEDICAL EMERGENCY ROOM AND LEARNED HIS KNEE WAS FRACTURED.

WHILE OFFICER MITCHELL WAS ARRESTING DAMIEM WEAVER, OFFICER QUALYNDREA JONES ATTEMPTED TO KEEP THE CROWD BACK. AT THAT TIME AN UNRULY W/F BEGAN TO PUSH AND PULL OFFICER JONES AS SHE ATTEMPTED TO ASSIST OFFICER MITCHELL. OFFICER JONES PLACED THE W/F IN HANDCUFFS AND ADVISED HER OF HER MIRANDA RIGHTS. OFFICER JONES ARRESTED NARI TOMASSETTI (W/F, DOB CONTINUED) FOR DISTURBING THE PEACE AND INTERFERING WITH A POLICE INVESTIGATION.

OFFICER CHAD COCKERHAM OBSERVED AN UNK W/F AS SHE CONSTANTLY KICKED OVER SEVERAL NEIGHBORHOOD TRASH CANS. THE W/F CONTINUED TO SHOW TOTAL DISREGARD FOR THE LAW AND BEGAN TO THROW OBJECTS INTO THE CROWD. OFFICER COCKERHAM PLACED THE SUBJECT UNDER ARREST AND ADVISED KATHRYN ABARBANEL (W/M, DOB CONTRACT) OF HER MIRANDA RIGHTS. THE SUSPECT WAS ARRESTED FOR DISTURBING THE PEACE BY TUMULTUOUS BEHAVIOR.

SIMULTANEOUSLY, OFFICERS CORBY SLAGLE AND JERMELL TAYLOR HEARD THE AIR AS IT ESCAPED FROM THE TIRE ON UNIT 531 AND OBSERVED AN UNKNOWN PARTICIPANT NEAR THE DAMAGED TIRE. DUE TO THE ONGOING VIOLENT BEHAVIOR OF THE PARTICIPANTS, OFFICERS HAD REASON TO BELIEVE THE SUBJECT MAY HAVE SLASHED THE TIRE OF THE POLICE UNIT. OFFICERS STOPPED THE SUBJECT TO INVESTIGATE. THE UNKNOWN PARTICIPANT, LATER LEARN TO BE WINFIELD BURDICK (W/M,), IMMEDIATELY BECAME VIOLENT AS HE SNATCHED AWAY FROM OFFICERS. OFFICERS SLAGLE AND TAYLOR BELIEVED THE SUBJECT WAS ARMED WITH A SHARP OBJECT. OFFICERS SLAGLE HANDCUFFED WINFIELD BURDICK AND ADVISED HIM OF HIS MIRANDA RIGHTS. INTOXICATED WINFIELD BURDICK CONSTANTLY INTERFERED WITH OFFICERS AS THEY ATTEMPTED TO INVESTIGATE. WINFIELD BURDICK BEGAN TO ENTICE THE CROWD BY RALLYING THEM TO CHANT, "LET HIM GO!" WINFIELD BURDICK DID NOT HAVE A WEAPON, BUT WAS ARRESTED FOR DISTURBING THE PEACE BY TUMULTUOUS BEHAVIOR.

THE UNRULY VIOLENT CROWD BEGAN TO CHANT "LET HIM GO, LET HIM GO, LET HIM GO!" THE CROWD THEN BEGAN TO THROW ROCKS AND TRASH AT THE POLICE. OFFICERS ATTEMPTED TO MAINTAIN ORDER, BUT THE INTOXICATED AND UNRULY MASSIVE VIOLENT PARTICIPANTS APPROACHED OFFICERS SHOUTING AS THEY QUESTIONED THE OFFICERS' REGARDING THE ARRESTS. THE SCENE SUDDENLY BECAME TOTALLY UNSAFE FOR THE AMOUNT OF OFFICERS VERSES THE AMOUNT OF INTOXICATED VIOLENT OFFENDERS. THE CROWD BEGAN TO THROW BOTTLES AT THE POLICE AND AN UNKNOWN UNIT KICKED IN A 10-55 (OFFICER NEED ASSISTANCE).

AN UNKNOWN WHITE MALE PARTICIPANT APPROACHED OFFICER WEATHERSBY AND SHOVED HIM TO HIS CHEST AREA THEN RAN OFF. OFFICER LAWRENCE WEATHERSBY AND TERRENCE DAVIS GAVE FOOT PURSUIT AND APPREHENDED THE SUBJECT IN THE 2600 BLOCK OF CHARTRES STREET. THE PERPETRATOR PHYSICALLY RESISTED THE OFFICERS AS THEY ATTEMPTED TO HANDCUFF HIM. OFFICER DAVIS ENGAGED IN A PHYSICAL STRUGGLE WITH THE SUBJECT AND THEY FELL TO THE GROUND. THE SUBJECT CONTINUED TO RESIST AS HE KICKED AT OFFICER WEATHERSBY WHO ATTEMPTED TO ASSIST. OFFICER WEATHERSBY PRODUCED HIS EXPANDABLE PATON AND STRUCK THE SUBJECT TO THE THIGH AREA 3 TIMES TO OBTAIN CONTROL OF THE PERPETRATOR. OFFICER DAVIS MANAGED TO PLACE THE HANDCUFFS ON THE UNKNOWN WHITE MALE PERPETRATOR.

WHILE OFFICERS DAVIS AND WEATHERSBY ESCORTED THE PERPETRATOR TO THE POLICE UNIT THE OFFICERS NOTICE THEY WERE SUDDENLY SURROUNDED BY APPROXIMATELY 100 VIOLENT PARADE PARTICIPANTS. THE PARTICIPANTS/ REVELERS REFUSED TO ALLOW THE OFFICERS TO WALK AWAY WITH THE PERPETRATOR. THE INTOXICATED PARTICIPANTS WERE YELLING AS THEY CHANTED "LET HIM GO, LET HIM GO!" (REFERRING TO THE PERPETRATOR). OFFICER WEATHERSBY THEN OBSERVED AN UNKNOWN WHITE MALE PRODUCE A BRICK AND THREW THE BRICK AT OFFICER WEATHERSBY. THE BRICK STRUCK OFFICER WEATHERSBY CAUSING A LUMP AND AN ABRASION TO OFFICER WEATHERSBY'S FOREHEAD, OFFICER WEATHERSBY CALLED IN A SIGNAL 10-55 VIA POLICE RADIO ON CHANNEL FOUR (4). AT THAT TIME THE VIOLENT REVELERS ADVANCED TOWARD THE OFFICERS. THE CROWD CREATED A DISTRACTION AS THEY PUSHED AND SHOVED AT THE OFFICERS AND PULLED ON THE ARRESTED SUBJECT TO ASSIST HIM IN HIS ESCAPE. THE ARRESTEE MADE GOOD AT HIS ESCAPE WITH THE AID OF MEMBERS OF THE CROWD. THE ARRESTEE WAS STILL HANDCUFFED, WITH HIS HANDS BEHIND HIS BACK WHEN LAST SEEN BY THE OFFICERS. OFFICER DAVIS ENGAGED IN A FOOT PURSUIT BEHIND THE ARRESTEE AND WAS DELIBERATELY TRIPPED BY AN UNRULY REVELER CAUSING HAND, LEG AND ELBOW INJURIES TO THE OFFICER, SIMULTANEOUSLY; OFFICER WEATHERSBY ENGAGED IN A FOOT PURSUIT BEHIND THE WHITE MALE WHO STRUCK HIM WITH THE BRICK. THAT SUBJECT "MADE GOOD AT HIS ESCAPE" DUE TO THE ASSISTANCE OF THE REVELERS WHO BLOCKED THE OFFICER'S PATH.

OFFICER WEATHERSBY FURTHER STATED AS HE WALKED TO RETURN TO HIS POLICE UNIT, AN UNKNOWN WHITE FEMALE JUMPED ON OFFICER WEATHERSBY'S BACK. OFFICER WEATHERSBY BELIEVED THE UNKNOWN WHITE FEMALE MAY HAVE BEEN THE GIRLFRIEND OF THE HANDCUFFED ARRESTEE THAT FLED. OFFICER WEATHERSBY MANAGED TO SHOVE THE UNKNOWN FEMALE OFF OF HIS BACK. AS OFFICER WEATHERSBY ATTEMPTED TO PLACE HER UNDER ARREST, THE UNKNOWN WHITE FEMALE BEGAN TO ADVANCE TOWARD HIM IN A THREATEN MANNER. OFFICER WEATHERSBY PRODUCED HIS ELECTRONIC CONTROL DEVICE AND DRIVE STUNNED THE UNKNOWN FEMALE TO THE UPPER TORSO, WHICH CAUSED HER TO FALL TO THE GROUND. AFTER THE UNKNOWN FEMALE WAS

TASED, A MASSIVE CROWD OF THE CHAOTIC REVELERS RUSHED THE OFFICER CAUSING HIM TO SEEK COVER. OFFICER WEATHERSBY STATED HE OBSERVED THE UNKNOWN FEMALE GET UP FROM THE GROUND AND FLED INTO THE CROWD BEFORE HE COULD EFFECT HER ARREST.

UNIT 1590, SGT. JAMES CLARKSTON OF THE 5TH DIST T/F "B" ARRIVED ON THE SCENE; SGT. CLARKSTON CANVASSED THE AREA FOR THE INJURED OFFICERS AND THE DAMAGE TO THE POLICE UNITS. SGT. CLARKSTON IMMEDIATELY OBSERVED THE DAMAGE TIRE OF UNIT 531. SGT. CLARKSTON MADE CONTACT WITH UNIT 1877, OFFICER LARRY ADAMS, OF THE 8TH DIST. OFFICER ADAMS HAD TIMOTHY ROTHBERGER (W/M, COMPARISON) IN THE REAR OF HIS POLICE UNIT. SGT. CLARKSTON LATER LEARNED THE SUBJECT WAS ADVISED OF HIS MIRANDA RIGHTS AND ARRESTED FOR INTERFERENCE WITH POLICE INVESTIGATION AND RESISTING AN OFFICER (AFFIDAVIT E81560).

WHILE OFFICERS CORBY SLAGLE AND TONY BURRELL ATTEMPTED TO DISBURSE THE CROWD AT THE INTERSECTION OF FRANKLIN AVE AND CHARTRES STREET. OFFICER BURRELL WAS STRUCK TO THE REAR OF THE HEAD BY AN UNKNOWN WHITE MALE. OFFICERS ENSUED IN A STRUGGLE AND THE SUBJECT CONTINUED TO BE COMBATIVE. OFFICER BURRELL ADVISED THE SUBJECT TO COMPLY OR HE WOULD BE TASED. THE SUBJECT REFUSED TO COMPLY AND OFFICER BURRELL DRIVE STUNNED THE SUBJECT. OFFICERS MANAGE TO HANDCUFF THE SUSPECT WITHOUT FURTHER INCIDENT. OFFICER SLAGLE ADVISED KELLY STILES (W/M, DOB HIS MIRANDA RIGHTS AND PLACED HIM UNDER ARREST FOR BATTERY ON A POLICE OFFICER, DISTURBING THE PEACE AND RESISTING ARREST.

SGT. CLARKSTON AND SGT. LACABE WERE ON THE SCENE AT THAT POINT. SGT. CLARKSTON OBSERVED LT. MICHEAL BRENKLE, UNIT 510A, AND SGT. RECCI FAYARD, UNIT 520A, BOTH OF THE 5TH DIST, ON THE SCENE STANDING AT THE INTERSECTION OF FRANKLIN AVE. AND CHARTRES ST.

SGT. CLARKSTON ADVISED SGT. LACABE THAT HE WOULD RELOCATE TO THE FRONT OF THE PARADE, THE BAND AREA, IN AN ATTEMPT TO STOP THE LEAD PORTION OF THIS ONGOING VIOLENT CROWD'S BEHAVIOR. WHILE IN THE PATROL UNIT 523, SGT. CLARKSTON WAS MET WITH THE VIOLENT CROWD WHO CONSTANTLY THREW TRASH CANS IN THE STREET TO IMMOBILIZE THE POLICE UNIT AS IT TRAVELED. SGT. CLARKSTON SUDDENLY OBSERVED OFFICER CLEVELAND JOHNSON EXIT HIS POLICE UNIT AND RUN TO ASSIST A FELLOW OFFICER. SGT. CLARKSTON EXITED HIS UNIT TO ASSIST.

SGT. CLARKSTON OBSERVED OFFICER TRENILE FRANKLIN ENGAGED IN A HEROIC STRUGGLE WITH AN UNK W/M. THE UNK W/M MANAGED TO BREAK THE STRUGGLE CAUSING OFFICER FRANKLIN TO FALL TO THE GROUND. OFFICER JOHNSON GAVE FOOT PURSUIT ON THE SUBJECT AND A STRUGGLE ENSUED. SGT. CLARKSTON ASSISTED IN THE STRUGGLE TO GAIN CONTROL OF THE SUBJECT. THE UNK W/M CONTINUED TO RESIST. OFFICER CLEVELAND JOHNSON PRODUCED HIS ECD AND DRIVE STUNNED THE SUBJECT. AT THAT POINT OFFICER JOHNSON MANAGED TO PLACE HANDCUFFS ON THE PERPETRATOR, WILLIAM WATKINS.

SUDDENLY AN UNK W/F, DELIBERATELY RAN HER BODY INTO A CROWD OF OFFICERS WHO WERE ATTEMPTING TO HANDCUFF THE UNK W/M. THE FEMALE DELIBERATELY RAN INTO THE OFFICERS WITH SUCH FORCE, SGT. CLARKSTON BELIEVED THE WHITE FEMALE WAS POSSIBLY ARMED WITH A DEVICE TO INJURE OFFICERS. THE FEMALE FELL TO THE GROUND AND SGT. CLARKSTON STOOD OVER THE WHITE FEMALE AS HE SUDDENLY BECAME SURROUNDED BY OVER 50 VIOLENT INTOXICATED PARTICIPANTS. THE PARTICIPANTS WERE CLOSING IN ON SGT. CLARKSTON AS THEY SHOUTED VULGAR WORDS OF "POLICE AIN'T SHIT", "FUCK YOU", "YOU SHOULD LET THE PARADE GO!" SGT. CLARKSTON SERIOUSLY FEARED FOR HIS SAFETY. SGT. CLARKSTON PRODUCED HIS EXPANDABLE PATON AND ORDERED THE CROWD TO GET BACK. SGT. CLARKSTON TRANSMITTED OVER THE POLICE RADIO A 10-55 (OFFICER IN NEED OF ASSISTANCE) SEVERAL TIMES ON CHANNEL FOUR (4). AT THAT TIME LAW ENFORCEMENT OF THE 1ST, 4TH, 8TH AND STATE TROOPERS ARRIVED AT THE LOCATION AND TOOK CONTROL OF THE AREA. THE SCENE BECAME SAFE AND SGT. CLARKSTON CONDUCTED THE APPREHENSION ON THE WHITE FEMALE. SGT. CLARKSTON ADVISED THE W/F, LATER LEARNED TO BE LISA REED (W/F, DOB OF HER MIRANDA RIGHTS. LISA REED WAS ARRESTED FOR DISTURBING THE PEACE BY TUMULTUOUS BEHAVIOR. SGT. CLARKSTON PLACED THE POLICE UNIT.

SGT. CLARKSTON SPOKE WITH OFFICER TRENILE FRANKLIN WHO STATED SHE ARRIVED TO ASSIST ON A 10-55(OFFICER NEED ASSISTANCE) AT CHARTRES AND PORT ST. AT THE LOCATION ONE OF THE VIOLENT PARTICIPANTS THREW A PIECE OF WHITE METAL AT THE OFFICER'S POLICE UNIT. OFFICER FRANKLIN EXITED HER UNIT AND APPROACHED THE SUBJECT TO AFFECT AN ARREST FOR THE VIOLATION. OFFICER FRANKLIN ADVISED THE SUBJECT HE WAS UNDER ARREST FOR THROWING THE PROJECTILE AT THE POLICE VEHICLE. AS SHE ATTEMPTED TO HANDCUFF HIM, THE SUBJECT BECAME VIOLENT AND RESISTED ARREST BY GRABBING THE OFFICER AND FORCED HER TO THE GROUND. OFFICER FRANKLIN RECEIVED AN INJURY TO HER LEFT KNEE, LACERATION TO HER RIGHT HAND AND A MINOR CONTUSION TO THE RIGHT SIDE OF HER FACE.

ADDITIONALLY, OFFICER TRENILE FRANKLIN'S PRESCRIPTION GLASSES AND HER NOPD ISSUED RADIO BATTERY WAS DAMAGED DURING THE ALTERCATION. OFFICER JOHNSON, UNIT 3854, RESPONDED TO ASSIST AND OBSERVED THE SUBJECT GRAB OFFICER FRANKLIN AND THROW HER TO THE GROUND. THE SUBJECT THEN FLED ON FOOT. OFFICER JOHNSON PURSUED THE SUBJECT AND ADVISED HIM TO STOP, BUT HE REFUSED. OFFICER JOHNSON ENGAGED THE SUBJECT AND AFTER A BRIEF STRUGGLE PERFORMED A TAKE DOWN ON THE SUBJECT. THE SUBJECT CONTINUED TO RESIST. OFFICER JOHNSON ADVISED THE SUBJECT TO STOP RESISTING OR HE WOULD BE TASED. THE SUBJECT DID NOT COMPLY AND OFFICER JOHNSON DRIVE STUNNED THE SUBJECT IN HIS MID TORSO. THE SUBJECT STILL RESISTED AND OFFICER JOHNSON ADVISED THE SUBJECT TO STOP OR HE WOULD BE TASED AGAIN. THE SUBJECT REFUSED TO COMPLY AND THE OFFICER TASED THE SUBJECT TO STOP OR HE WOULD BE TASED AGAIN. THE SUBJECT REFUSED TO COMPLY AND THE OFFICER JOHNSON TO PLACE HANDCUFFS ON HIM. OFFICER JOHNSON ADVISED THE SUBJECT OF HIS MIRANDA RIGHTS. THE ARRESTED SUBJECT IDENTIFIED AS WILLIAM WATKINS (W/M, DOB WAS CHARGED WITH BATTERY ON A POLICE OFFICER, RESISTING ARREST AND CRIMINAL DAMAGE TO PROPERTY.

WHEN SGT. CLARKSTON REQUESTED A 10-55 (OFFICER IN NEED OF ASSISTANCE), OFFICER CHAD COCKERHAM RESPONDED WITH ADDITIONAL POLICE UNITS. AS OFFICER COCKERHAM ASSISTED IN DISBANDING THE MASSIVE CROWD, HE WAS IMMEDIATELY MET

WITH RESISTANCE FROM AN UNK B/M WHO REFUSED TO DISBURSE. OFFICER COCKERHAM ADVISED THE SUBJECT TO MOVE ON SEVERAL TIMES, YET HE REFUSED. THE SUBJECT CONTINUED TO DISPLAY HIS LOUD DISORDERLY BEHAVIOR AS TO DISREGARD THE OFFICER'S REQUEST TO MOVE ON. OFFICER COCKERHAM PLACED THE SUBJECT UNDER ARREST. OFFICER COCKERHAM ADVISED RONALD MORRISON (B/M, DOB THE SUBJECT) OF HIS MIRANDA RIGHTS AND PLACED HIM IN THE POLICE UNIT.

IT WAS ALSO LEARNED THAT THE LAW ENFORCEMENT OFFICERS OF THE NEW ORLEANS POLICE DEPARTMENT DISTRICTS 1ST, 4TH, 5TH, 8TH AND STATE TROOPERS THAT RESPONDED TO THE 10-55 (OFFICER IN NEED OF ASSISTANCE) HAD ENCOUNTERED TOTAL RESISTANCE FROM THE VIOLENT CHAOTIC REVELERS. THE REVELERS WERE COMBATIVE AND SHOWED NO SIGNS OF COMPLYING WITH THE LAW.

AS SGT. CLARKSTON WAS PLACING THE ARRESTED SUBJECT, LISA REED, IN THE POLICE UNIT, OFFICERS BEGAN TO SHOUT "MACE, MACE, WHO HAS MACE?" SGT. CLARKSTON RELEASED HIS CANISTER OF OLEORESIN CAPSICUM (OC) SPRAY TO OFFICER JOSEPH DAVIS WHO SPRAYED THE CROWD OF PARTICIPANT IN AN ATTEMPT TO GAIN ORDER. SGT CLARKSTON OBSERVED ANOTHER• UNKNOWN OFFICER AS HE ASSISTED OFFICER J. DAVIS OC SPRAYED THE CROWD. AT THAT POINT THE CHAOTIC REVELERS BEGAN TO DISBURSE. MOMENTS LATER THE STREET BECAME CLEAR AND SLIGHTLY CALM. AFTER THE OFFICERS OBTAINED A SLIGHTLY CALM ENVIRONMENT, OFFICERS ASSISTED IN REMOVAL OF THE TRASH CANS FROM THE STREET.

E.M.S., UNIT 6200, OPERATED BY DOCTOR JEFF ELDER WAS SUMMONED TO THE SCENE FOR ANY INJURED INDIVIDUALS TO COME FORWARD WITH THEIR COMPLAINT OF INJURY. EMS WAS ON THE SCENE FOR AT LEAST 15-20 MINUTES, ON STANDBY, AS THEY EXAMINED INJURIED INDIVIDUALS.

NOTE: NONE OF THE REVELERS CAME FORWARD AND REQUESTED MEDICAL ASSISTANCE.

SGT. CLARKSTON REQUESTED ALL OFFICERS TO RELOCATE THEIR ARRESTED SUBJECTS TO THE INTERSECTION OF FRANKLIN AVE. AND ST. ROCH STREET. SERGEANTS AND OFFICERS WERE BRIEFED BY FIFTH DISTRICT D.I.U. COMMANDER, LT. LASALLE RATLER, OF THE FIFTH DISTRICT. LT. RATTLER INSTRUCTED THE SERGEANTS AND THE OFFICERS TO CLEAR THE SCENE AND RELOCATE THE ARRESTED SUBJECTS TO THE FIFTH DISTRICT STATION TO CONDUCT THE PAPERWORK FOR ARREST.

SEVERAL OFFICERS REMAINDED ON THE SCENE TO CHANGE TIRES ON THE DAMAGED POLICE VEHICLES. LT. RATLER ASSIGNED ADDITIONAL OFFICERS TO STANDBY ON THE SCENE WHILE THE OFFICERS CHANGED TIRES TO PROVIDE SAFETY FOR THE OFFICERS

WHILE AT THE FIFTH DISTRICT POLICE STATION, IT BECAME APPARENT THAT THERE WERE UNITS THAT ARRIVED AND ASSISTED IN ESTABLISHING ORDER, BUT LEFT THE LOCATION BEFORE PROVIDING ANY DETAILS OR INFORMATION REGARDING THEIR ARREST. SGT. CLARKSTON LEARNED TWO REVELERS OF THE UNRULY CROWD WERE PLACED INSIDE OF THE POLICE UNITS DURING THE CHAOTIC RIOT OF THE UNAUTHORIZED PARADE. THE SUBJECTS WERE PLACED UNDER ARREST AND HANDCUFFED.

NOTE: DUE TO THE TWO REVELERS BEING IN AN INTOXICATED CONDITION AND PLACED IN THE POLICE UNITS DURING THE HIGH POINT OF THE DISRUPTION, OFFICERS DID RECOGNIZED THE REVELERS AS SUBJECTS OBSERVED THROWING TRASH CANS DURING THE HEIGHT OF THE CHAOTES.

SGT. CLARKSTON ADVISED THE TWO REVELERS, JOHNATHAN CROMWELL (W/M, DOB (CARA)) AND ANGELYSE FISHER (W/F, (CARA)), OF THEIR MIRANDA RIGHTS AND BOTH WERE CHARGED WITH DISTURBING THE PEACE BY TUMULTUOUS BEHAVIOR.

DUE TO REVELER KELLY STILES BEING DRIVE STUNNED DURING HIS CHAOTIC BEHAVIOR AND COMPLIANT OF BEING TOUCH STUN, OFFICERS Q. JONES AND SLAGLE TRANSPORTED KELLY STILES TO UNIVERSITY HOSPITAL TO BE EXAMINED.

THE ARRESTED SUBJECTS LISTED BELOW WERE TRANSPORTED TO CENTRAL LOCK-UP AND RELEASED TO O.P.S.D. TO BE BOOKED ACCORDINGLY.

WHILE AT THE 5TH DIST POLICE STATION SGT. STUART SMITH OF THE 8TH DIST T/F "B" AUTHORED A HAND WRITTEN STATEMENT IN REGARD TO THE 8TH DIST PARTICIPATION OF THE UNAUTHORIZED PARADE. A SHORT VERSION OF SGT. SMITH'S HAND WRITTEN STATEMENT WAS INDICATED IN THE FIRST TWO PARAGRAPH OF THIS REPORT. THE LONG VERSION HAND WRITTEN REPORT WILL BE ATTACHED TO THIS REPORT.

SGT. CLARKSTON MANAGED TO OBTAIN INDIVIDUAL OFFICERS' STATEMENTS THE FOLLOWING DAY OF THE INCIDENT. AT WHICH TIME IT WAS LEARNED THAT THREE (3) OF THE ARRESTED REVELERS WERE ACTUALLY TASED, BUT ONLY ONE (1), KELLY STILES, COMPLAINT OF BEING TASED.

LT. MICHAEL BRENCKLE STATED ON SUNDAY, MARCH 6, 2011, AT 10:47 PM, HE WAS IN UNIT 510A ALONG WITH SGT RICCI FAYARD IN UNIT 530A.

UPON ARRIVAL, LT. BRENCKLE OBSERVED A LARGE CROWD OF PEOPLE ENGAGED IN A PARADE AND A PUNGENT ODOR OF MARIJUANA FILLED THE AIR. LT. BRENCKLE OBSERVED SEVERAL 5TH DIST TASK FORCE OFFICERS YELLING, "PLEASE DISPERSE, PLEASE MOVE ON!" ADDITIONALLY, LT. BRENCKLE OBSERVED OFFICER Q. JONES ATTEMPTING TO PLACE A W/F IN HANDCUFFS, LT. BRENCKLE IMMEDIATELY ASSISTED OFFICER JONES IN HANDCUFFING THE FEMALE SUBJECT WHO WAS INTOXICATED.

LT. BRENCKLE OBSERVED NUMEROUS INDIVIDUALS INVOLVED IN THE PARADE TAUNTING AND YELLING PROFANITIES AT THE OFFICERS.

LT. BRENCKLE AND SGT. FAYARD REMAINED ON THE SCENE UNTIL THE INCIDENT CALMED DOWN. LT. BRENCKLE AND SGT. FAYARD LEARNED OFFICER TRENILLE FRANKLIN WAS INJURED. THEY TRANSPORTED HER TO TULANE MEDICAL CENTER FOR TREATMENT. WHILE AT THE HOSPITAL, SEVERAL TASK FORCE OFFICERS ARRIVED TO BE TREATED FOR THEIR INJURIES RECEIVED IN THE ALTERCATION. LIEUTENANT BRENCKLE COMPLETED NECESSARY PAPERWORK FOR THE OFFICERS TO BE TREATED.

USE OF FORCE:

SGT. CLARKSTON LEARNED THE LISTED OFFICERS BELOW UTILIZED THEIR TASER TO OBTAIN ORDER AND TO AFFECT AN ARREST DURING THE RIOT.

1.P/O CLEVELAND JOHNSON PRODUCED HIS ECD AND DRIVE TASED ARRESTED SUBJECT WILLIAM WATKINS TO AFFECT THE ARREST. 2.P/O JOSEPH DAVIS PRODUCED HIS EDC AND DEPLOYED IN AN ATTEMPT TO TASE MICAH MARTIN, BUT THE PRONE MADE AN IMPROPER CONTACT WHICH CAUSED NO FORCE OF ACTION.
