

Narrative

On Saturday, November 26, 2011, approximately 1230 hours, Sergeant Williams Holmes, a member of Orleans Parish Sheriff's Office (O.P.S.O.), assigned as a Watch Commander for the House of Detention Facility (H.O.D.) which is located at 2735 Perdido Street, stated he walk into the H.O.D. facility control office when he observed a black jacket hanging in the office. Sergeant Holmes went on by stating he placed the black jacket on his person, at which time he (Holmes) noticed the jacket contained a Silver Boost Mobile cellular telephone and black charger in the left pocket. Sergeant Holmes stated he was advised by Sergeant Nicole Harris, who is also a member of the O.P.S.O., assigned to the H.O.D. facility, the black jacket belonged to Deputy Michael Conerly (B/M, D.O.B. 4-3-11), who is also a member of the O.P.S.O., assigned to H.O.D. facility.

At approximately 1300 hours, Deputy Ernest Newman, who is a member of the O.P.S.O., assigned to the Special Operations Division (S.O.D.), conducted an interview with Sergeant Harris. Sergeant Harris began stating she confiscated the jacket from Deputy Conerly when he arrived for shift. Sergeant Harris continued by explaining she advised Deputy Conerly the jacket was not a departmental issued jacket. Sergeant Harris added by stating she gave Deputy Conerly a departmental issued green sheriff's jacket and placed Deputy Conerly's black jacket in the H.O.D. control office. Sergeant Harris ended by stating Sergeant Holmes put Deputy Conerly's jacket on his person and found a cellular telephone in the left pocket.

At approximately 1400 hours, Deputy Jerry Martin and Deputy Fredrick Brooks both members of the O.P.S.O., assigned to the S.O.D., relocated back to the S.O.D office along with Deputy Conerly. Deputy Newman and Deputy Brooks conducted an interview with Deputy Conerly. Before the interview began, Deputy Newman advised Deputy Conerly of his Constitutional Rights per Rights of an Arrestee or Suspect form number 100386 . Deputy Conerly stated he understood his rights and signed the form, and agreed to cooperate with the investigation. Deputy Newman questioned Deputy Conerly about the cellular telephone found in his jacket pocket while in the jail. Deputy Conerly admitted he brought the phone in the jail for inmate Lorenzo "Woodie" Peters. Deputy Conerly also admitted he has brought in cellular telephones in the jail on two other occasions. Deputy Conerly was then advised he was being booked for three counts of violation of La.R.S. 14: 402, relative to Introduction of Contraband into a Penal Institution and three counts of La. R.S. 14: 134, relative to Malfeasance in Office. Deputy Conerly was booked accordingly at the O.P.S.O Intake and Processing Center (I.P.C.) under New Orleans Police Department (N.O.P.D.) item number K-37958 -11
