The Court was advised that the plaintiffs, the Sheriff of Orleans Parish, and the United States of America are in agreement that changes need to be made to ensure the constitutionality of conditions at Orleans Parish prison facilities. The Court was further advised that the City of New Orleans will not agree that such changes are needed until any dispute regarding funding is resolved. Accordingly,

In view of the City's position, IT IS ORDERED that a trial to determine whether conditions at Orleans Parish prison facilities are constitutional is scheduled for Tuesday, February 19, 2013, at 8:30 a.m.

IT IS FURTHER ORDERED that a pretrial conference for this trial is scheduled for Friday, February 1, 2013, at 7:30 a.m.

IT IS FURTHER ORDERED that on or before Wednesday, January 30, 2013, the parties shall submit briefing on the standard to be applied by the Court to evaluate the constitutionality of conditions at Orleans Parish prison facilities with respect to medical care, mental health care, security, and general prison conditions.

IT IS FURTHER ORDERED that a trial is scheduled for Monday, April 1, 2013, at 8:30 a.m. to determine the funding needed to ensure constitutional compliance and the source(s) responsible for providing that funding. For purposes of preparing for this trial, the parties are to assume that the conditions identified by plaintiffs are unconstitutional.

IT IS FURTHER ORDERED that a pretrial conference for this trial is scheduled for Tuesday, March 5, 2013, at 7:30 a.m.

IT IS FURTHER ORDERED that the case be re-allotted to U.S. Magistrate Judge Alma L. Chasez.
