### **PETITION FOR DAMAGES**

The petition of Darleen Mipro, a person of the full age of majority, resident of and residing in Orleans Parish, State of Louisiana, who respectfully represents:

1.

Made defendant herein is:

**Jean Montes**, individually, and as a member of the **LFNO** Board, a person of the full age of majority, resident of and domiciled in the Parish of Orleans at 7471 Pitt Street, New Orleans, La 70118;

**Paige A. Saleun**, individually, and as a member of the **LFNO** Board, and a person of the full age of majority, resident of and domiciled in the State of Louisiana; and

Lycee Francais De La Nouvelle Orleans, Inc. (hereinafter referred to as "LFNO"), a non-profit charter school whose domicile is 5401 S. Claiborne Avenue, New Orleans, La, who are truly and justly indebted unto your petitioner for the following reasons to-wit:

2.

At all times relevant prior to November 30, 2012 and since the opening of **LFNO** charter school, petitioner has been a special education coordinator and English Chair, also teaching second grade and gifted classes. At approximately 2:45 p.m. on Friday, November 30, 2012 petitioner was in the normal scope of her duties as a faculty member when she was asked by Julianne Ruocco, the business manager, to follow her to her office. After arriving at the office, petitioner was advised she was being terminated for misconduct. Upon inquiring as to what misconduct, petitioner was told that it had come to the "attention of the School Board" that she had somehow tampered with the school's website. Further, she was also accused of organizing the teachers against the Board.

Despite complete denial of the accusations as stated above, petitioner was then met by Jean Montes, President of LFNO and Chairman of the school's Board. Mr. Montes stated that he was there as a witness, however, during the entire confirmation of her discharge, he was communicating with other members of the faculty and parents. Because of the events, petitioner started to call her husband on her cell phone. Defendant Jean Montes at that point told her she was not allowed to use her cell phone, or retrieve her purse and keys. Additionally, she was informed by defendant Montes that neither she nor her husband would be permitted on the premises including picking up or dropping off her son who also attended first grade at LFNO.

4.

Petitioner again asked several times if she could get her purse and keys as well as pick up her son from the first grade. Eventually, defendant **Jean Montes** told her she would have to be escorted from the school and come back later when school was not in session to get her belongings. At this point, petitioner was advised that she could not leave the premises as the police had been called prior to her being brought into the office to be discharged.

5.

Eventually, with petitioner in tears, **Jean Montes** asked the business manager, Julianne Ruocco to escort petitioner to her classroom to retrieve her purse. On the way to her class, petitioner was met by a few French teachers, one of whom asked the business manager if petitioner could say goodbye to her class. At that point, the French teacher led petitioner to her classroom, where she politely said goodbye to the children she had taught, and then returned to the business office.

6.

After returning to the business office, petitioner was told to sit down and wait for the police to arrive. While waiting, petitioner learned that an email had been sent to the parents of the entire student body, including students who were no longer at LFNO, stating that Darleen Mipro had been fired for "engaging in misconduct", Exhibit A, (the response to this email and web comments was overwhelming, see Exhibit B). When the police officer arrived, he escorted petitioner and her son to his car which was stationed by the carpool pick up line, such that all of the arriving parents could see petitioner and her son both crying, being detained by the New

Orleans Police Department. Also present in this area was defendant Jean Montes and defendant Board Member Paige A. Saleun, busily informing arriving parents that Darleen Mipro was being charged with criminal misconduct and disturbing the peace. Many parents in the carpool line stopped to inquire as to what was going on and were told that Jean Montes had Darleen Mipro arrested for criminal misconduct. Petitioner was issued a summons for the above described criminal conduct.

7.

At approximately 4:15 p.m. petitioner was allowed to leave with her son.

8.

When petitioner arrived at home, she was greeted with numerous phone calls and emails confirming that **Jean Montes** and **Paige A. Saleun** had been publishing events of the day and that petitioner was terminated for engaging in misconduct, and arrested for criminal misconduct and disturbing the peace. These emails had been sent to parents, even those whose children were no longer at **LFNO**.

9.

On or about December 3, 2012 at 8:30 a.m. petitioner appeared in court to plead not guilty for the criminal charges for disturbing the peace and criminal trespassing.

10.

At all times relevant on November 30, 2012 petitioner was on the school premises as a result of her faculty/employment position with **LFNO**. At 2:45 p.m. when she was terminated, petitioner was told by defendant **Jean Montes** that she could not leave the school as they had already called the police before even terminating her, and that she was being held until the police arrived. Further, petitioner was prohibited from making phone calls to her husband, prohibited from getting her son from class and prohibited from getting her purse and keys from her classroom. Petitioner remaining on the premises after 2:45 p.m. was at the request of **Jean Montes**.

11.

Petitioner alleges that the oral and written comments by defendants Jean Montes and Paige A. Saleun accusing petitioner of disturbing the peace, criminal trespass and misconduct, are completely false, fabricated, constitute defamation and defamation per se, and are intended to cast petitioner in a false light that would support their collusion in petitioner's improper

termination. Said action by defendants is also beyond their authorized acts as Board Members and are ultra vires. At all times relevant defendants **Jean Montes** and **Paige A. Saleun** were in the course and scope of their employment for **LFNO** and the School Board, and their acts are attributable to **LFNO** school under the principle of *respondeat superior* 

12.

In addition to the oral statements made by defendants Jean Montes and Page A. Saleun in publicizing that petitioner had engaged in criminal misconduct, criminal trespass and disturbing the peace, within minutes the LFNO administration approved and sent emails to all families, both attending the school and those no longer attending the school, in which they suggested the alleged misconduct including suggesting criminal activity and possible safety issues for the children. Within minutes after the email of November 30, 2012 appeared on the internet, hundreds of comments began circulating among the family members via Facebook, many inquiring as to exactly what criminal misconduct involved Darleen Mipro and her dismissal, Exhibit C in globo.

13.

As a result of the false, defamatory, defamatory per se statements by the defendants your petitioner has sustained damage to her reputation as an educator and parent, such that such information circulated in the school systems would cast a false light on petitioner and influence and prevent her from being hired by another school. Petitioner alleges she is entitled to all damages, as reasonable under the premise to be determined by the trier of fact.

WHEREFORE, your petitioner prays that the defendants Jean Montes, Paige A. Saleun, and Lycee Francais De La Nouvelle Orleans, Inc., be served with a copy of this petition, that they be duly cited to appear and answer same, and after all proceedings there be a judgment in favor of your petitioner for all amounts as reasonable under the premise, for the defamatory per se, defamatory statements and acts of the defendants in falsifying allegations and charges against petitioner merely for the purpose of terminating her, for which petitioner is entitled to damages, all as reasonable under the premises; said judgment against the defendants, Jean Montes, Paige A. Saleun, and Lycee Francais De La Nouvelle Orleans, Inc., jointly severally and *in solido*, together with legal interest from the date of demand until paid, for all cost of these proceedings, and for all general and equitable relief.

I sincerely thank you for your continued support of the school.






