LYCÉE FRANÇAIS ENGAGES LAW FIRM ADAMS AND REESE

Law Firm Assisting School in Public Records Requests and Litigation with Former Teacher

(New Orleans, LA) – Lycée Français de la Nouvelle-Orléans has engaged the law firm Adams and Reese LLP to represent it on general legal matters, the school's Board of Directors announced at its regular board meeting earlier this month.

Firm attorneys Lee C. Reid and Jaimmé Collins are assisting the school in responding to numerous public record requests from The Lens, an online publication covering area charter schools. Mr. Reid has been instrumental in the development of charter schools across Louisiana, representing a diverse array of stakeholders and dedicating numerous hours of pro bono assistance to improving the environment for charter schools in the state. His significant contributions include guiding many of the charter schools in Louisiana through the charter application process, assisting in all operational aspects, drafting legislation and policy, lobbying at the local and state level, representing charter schools on various study groups and assisting in the formation of charter school advocacy organizations.

Ms. Collins focuses her practice on commercial litigation and general business, working on cases involving contract disputes, disputes between corporate directors and shareholders, commercial insurance disputes and personal injury cases. She also serves as general counsel to a number of boards of directors and has lobbied for and against legislation that impacts education across Louisiana, particularly legislations affecting charter schools.
