

NARRATIVE

ON WEDNESDAY 01/25/2012 AT ABOUT 12::52 PM, OFFICER TIWANA CONWAY UNIT 277 A OF THE SECOND DISTRICT HAD THE OCCASION TO INVESTIGATE A SIGNAL 67E THEFT BY EMBEZZLEMENT AT 5624 FRERET ST (LUSHER CHARTER SCHOOL).

UPON ARRIVAL TO THE ABOVE MENTIONED LOCATION OFFICER CONWAY MET WITH THE REPORTING PERSON LYNDEN SWAYZE WHO IS THE CHIEF FINANCIAL OFFICER FOR LUSHER SCHOOL. MRS. SWAYZE STATED SOMETIME IN DECEMBER 2011, SHE PREPARED TO WRITE SOME CHECKS AND NOTICED THAT THE CHECK NUMBERS WERE OUT OF ORDER. MRS. SWAYZE NOTICED SOME CHECKS MISSING FROM THE LARGE STOCK OF CHECKS THAT ARE KEPT INSIDE OF A FILE CABINET INSIDE OF THE BUSINESS OFFICE.

THE BUSINESS OFFICES ARE LOCATED ON THE SECOND FLOOR OF THE SCHOOL ROOM NUMBERS 203 AND 201B. MRS. SWAYZE STATED ABOUT SIX PEOPLE HAVE ACCESS TO THE BUSINESS OFFICES. MRS. SWAYZE STATED SHE USUALLY KEEPS THE LARGER BOX OF CHECKS INSIDE OF A LOCKED FILE CABINET IN THE BUSINESS OFFICE. MRS. SWAYZE STATED THE DOORS TO THE BUSINESS OFFICE ARE USUALLY LOCKED WHEN THE ROOMS ARE UNOCCUPIED BY THE FINANCE STAFF.

MRS. SWAYZE STATED SHE DECIDED TO CONDUCT AN INVESTIGATION TO LOOK FOR THE MISSING CHECKS WITHOUT INFORMING HER OFFICE STAFF. MRS. SWAYZE STATED SHE DECIDED TO LET THE REST OF THE FINANCE STAFF KNOW ABOUT THE INVESTIGATION ON TUESDAY 01/24/12. MRS. SWAYZE STATED ABOUT AN HOUR LATER SHE WAS APPROACHED BY AN EMPLOYEE NAMED LAUREN HIGHTOWER WHO ASKED IF SHE COULD SPEAK TO HER REGARDING THE MISSING CHECKS.

MRS. SWAYZE STATED MS. HIGHTOWER TOLD HER THAT SHE HAD TAKEN 11 CHECKS FROM THE BOX OF CHECKS AND CASHED ONE CHECK IN THE AMOUNT OF \$5000.00. MRS. SWAYZE STATED MS. HIGHTOWER THEN STATED TO HER THAT SHE REPLACED THE MONEY AND SHREDDED THE OTHER 10 CHECKS THAT WERE LEFT. MRS. SWAYZE STATED SHE IMMEDIATELY NOTIFIED THE CEO OF THE SCHOOL MRS. KATHLEEN RIEDLINGER REGARDING THE INCIDENT.

AFTER NOTIFYING MRS. RIEDLINGER, MS. HIGHTOWER WAS ASKED TO SURRENDER HER KEYS TO THE OFFICE AND LEAVE THE CAMPUS. MRS. SWAYZE STATED SHE CONTINUED TO LOOK FOR EVIDENCE REGARDING THE INCIDENT. MRS. SWAYZE NOTIFIED WHITNEY NATIONAL BANK REGARDING THE INCIDENT BECAUSE ALL THE BANK STATEMENTS THAT CONTAINED THE IMAGES COPIES OF WRITTEN CHECKS HAD BEEN SHREDDED BY HIGHTOWER MRS. SWAYZE STATED SHE REQUESTED THE CHECK IMAGES OF WRITTEN CHECKS FROM THE BANK.

MRS. SWAYZE STATED AFTER HER REQUEST FOR INFORMATION FROM THE BANK, SHE WAS ABLE TO NARROW DOWN FIVE TRANSACTIONS OF CHECKS WRITTEN PAYABLE TO LAUREN HIGHTOWER IN THE AMOUNT OF \$5000.00 EACH. THERE WAS ONE CHECK IN THE AMOUNT OF \$800.00 PAYABLE TO CASH THAT WAS DEPOSIT ONLY.

MRS. SWAYZE ADVISED THE CHECKS IMAGES ALSO SHOWED FORGED SIGNATURES IN THE NAME OF KATHLEEN RIEDLINGER, BRENDA BOURNE THE MIDDLE SCHOOL PRINCIPAL, WILEY ATTES HIGH SCHOOL PRINCIPAL AND HER NAME ALSO. MRS. SWAYZE ADVISED THE ABOVE NAMED PEOPLE ARE THE ONLY PEOPLE AUTHORIZED TO SIGN CHECKS, ISSUED BY THE SCHOOL.

AFTER SPEAKING WITH MRS. SWAYZE OFFICER CONWAY MET. WITH KATHLEEN RIEDLINGER AT ABOUT 3:00 PM, AND SHE ADVISED OFFICER CONWAY THAT SHE DID NOT AUTHORIZE LAUREN HIGHTOWER TO WRITE ANY CHECKS PAYABLE TO HERSELF. MRS. RIEDLINGER ALSO STATED THAT SHE DID NOT SIGN ANY OF THE CHECKS MADE PAYABLE TO HIGHTOWER.

ON WEDNESDAY 01/25/11 AT ABOUT 3:10 PM, OFFICER CONWAY SPOKE WITH BOTH BRENDA BOURNE AND WILEY ATES VIA TELEPHONE AND BOTH MR. ATES AND MS. BOURNE ADVISED OFFICER CONWAY THAT THEY DID NOT AUTHORIZE LAUREN HIGHTOWER TO WRITE OR SIGN THIER SIGNATURE ON ANY OF THE CHECKS MADE OUT PAYABLE TO LAUREN HIGHTOWER.

OFFICER CONWAY CONFISCATED THE COPIES FROM MRS. SWAYZE AND RELOCATED TO CENTRAL EVIDENCE AND PROPERTY WHERE THE DOCUMENTS WERE PLACED ON THE BOOKS AS EVIDENCE UNDER RECEIPT NUMBER A3473312. OFFICER CONWAY ALSO OBTAINED A SIGNED THEFT AFFIDAVIT FOR THIS INCIDENT.

OFFICER CONWAY NOTIFIED SGT. ERNIE JOSEPH UNIT 280 A OF THIS INCIDENT. OFFICER CONWAY ALSO NOTIFIED SECOND DISTRICT DETECTIVE GUY SWALM UNIT 1221. OFFICER CONWAY NOTIFIED WHITE COLLAR CRIMES DETECTIVE M. RILEY UNIT 4233 OF THIS INCIDENT.

AFTER SPEAKING WITH SGT. JOSEPH AND DETECTIVE RILEY OFFICER CONWAY WAS ADVISED BY DETECTIVE RILEY THAT HE WOULD OBTAIN AN ARREST WARRANT ON LAUREN HIGHTOWER DUE TO THE FACT THAT THE SCHOOL WAS STILL GATHERING MORE INFORMATION FROM THE BANK REGARDING THE STOLEN CHECKS. OFFICER CONWAY ISSUED MRS. SWAYZE AN N.O.P.D. ITEM NUMBER FOR THIS INCIDENT.
