The school promises an excellent educational experience for the children there, highlighted by energetic and inspiring teachers and a treasured relationships with the French government and the Audubon Nature Institute. I would like to help the school reach the vision that inspired people like me who enrolled their children there before the school was even opened.

I believe my experience in mental health and educational assessment would provide a major advantage to the board. As a clinical psychologist, I have an interest in children's health and well-being. In the modern school, leaders must be able to fully understand issues such how to create and implement individual educational plans for children with disabilities, deal with modern forms of bullying, maneuver around the fast-changing roles of social media and electronic communication, and understand how changing social norms and family constellations can affect children in the school setting. Schools can only do so much, but understanding child psychology and child development allows schools to make strong, decisive stances against school violence, for example, without taking rash acts like expelling a 7-year-old boy who bit his breakfast pastry into a pop-gun, as one school in Maryland famously did earlier this year.

In addition, I have experience as a professional journalist with a master's degree in that field. I would seek to use my experience as a journalist to nurture positive relationships with Lycee Francais parents, faculty, staff, and the community at large by providing candor, transparency, and a non-defensive attitude. At times media coverage of Lycee Francais has seemed unfair. I believe in the role of a free press that, although sometimes adversarial, provides a form of accountability. I would seek to work with the public and the press in a way that encourages a full, fair understanding of the school. Such coverage, when complete, would necessarily have a more balanced view of the positive achievements that Lycee Francais is making in the community and the lives of its students.
