ON 4-9-2011 AT 1110 HOURS, I WAS DISPATCHED TO 836 DONNA DRIVE IN HARVEY, LOUISIANA IN REFERENCE TO A SIGNAL 103, DOMESTIC DISTURBANCE.

DISPATCH ADVISED THAT THEY RECEIVED A CALL FROM BOTH PARTIES INVOLVED AND BOTH ADVISED THAT THEIR SPOUSES WERE ATTACKING THEM UNPROVOKED AND REQUESTED JPSO.

UPON ARRIVAL I MET WITH JUNE HOLMES WHO ADVISED THAT SHE WAS IN A VERBAL ARGUMENT WITH HER HUSBAND WILLIAM HOLMES. SHE ADVISED THAT HER HUSBAND WAS YELLING AND SHOUTING AT HER CALLING HER VULGAR NAMES THEN PICKED UP A HAND GUN AND POINTED IT AT HER WHILE THREATENING HER. SHE ADVISED THAT SHE WAS AFRAID FOR HER SAFETY SO SHE RAN INTO THE BATHROOM AND LOCKED THE DOOR. JUNE HOLMES ADVISED THAT HER HUSBAND CONTINUED TO YELL AT HER THROUGH THE LOCKED BATHROOM DOOR BEFORE EVENTUALLY KICKING THE DOOR INWARDS AND GRABBING HER BY THE BACK OF THE NECK AND HAIR RIPPING HER WIG OFF. SHE ADVISED THAT STILL AFRAID FOR HER SAFETY SHE GRABBED A CAN OF PEPPER SPRAY AND SPRAYED HER HUSBAND, WILLIAM HOLMES IN THE EYES AND CALLED 911. JUNE HOLMES ADVISED THAT WHILE SHE WAS CONTACTING JPSO HER HUSBAND QUICKLY RAN TO HIS TRUCK AND HID HIS FIREARM HE THREATENED HER WITH INSIDE THE LOCKED VEHICLE. LET IT BE NOTED THAT JUNE HOLMES ADVISED THAT SHE DID NOT THREATENED HER HUSBAND AND ONLY SPRAYED HIM WITH PEPPER SPRAY IN SELF DEFENSE.

I THEN SPOKE WITH WILLIAMS HOLMES WHO ADVISED THAT HE WAS IN A VERBAL ARGUMENT WITH HIS WIFE JUNE HOLMES WHEN SHE BECAME VIOLENT AND PICKED UP A LARGE KITCHEN KNIFE AND LUNGED TOWARDS HIM AND THREATENED HIM. HE ADVISED THAT SHE THEN SET THE KNIFE DOWN AND GRABBED A CAN OF PEPPER SPRAY AND SPRAYED HIM IN THE EYES FOR NO REASON OTHER THEN SHE WAS UPSET AND "SNAPPED". WILLIAMS HOLMES ADVISED THAT SHE CONTINUED TO YELL AT HIM AND THREATENED HIM SO HE CONTACTED 911. LET IT BE NOTED THAT WILLIAM HOLMES ADVISED THAT HE DID NOT HARM HIS WIFE JUNE HOLMES OR THREATEN HER AT ANYTIME. HE ADVISED THAT HE NEVER KICKED IN THE BATHROOM DOOR AND ONLY HIS WIFE WAS VIOLENT. WILLIAM HOLMES ALSO ADVISED THAT HE DID NOT HAVE A GUN DURING THE ALTERCATION, BUT HE DOES HAVE A FIREARM HIDDEN INSIDE HIS LOCKED VEHICLE OUT FRONT OF THE RESIDENCE.

DURING MY INVESTIGATION I OBSERVED BOTH SUBJECTS CRYING AND ALSO THREE SMALL CHILDREN THAT WERE PRESENT DURING THE ALTERCATION TEARFUL AND CRYING. THE HOUSE SHOWED OBVIOUS SIGNS OF A DISTURBANCE WITH MULTIPLE ITEMS ON THE GROUND. INSIDE THE KITCHEN I OBSERVED A LARGE KNIFE MATCHING THE DESCRIPTION THE HUSBAND GAVE THE KNIFE THE WIFE THREATENED HIM WITH. THE KNIFE WAS ON TOP OF A COUNTER ALONE APPEARING OUT OF PLACE. INSIDE THE BEDROOM I COULD SMELL A STRONG SCENT CONSISTENT WITH PEPPER SPRAY AND I OBSERVED A CAN OF PEPPERY SPRAY ON THE FLOOR OF THE BATHROOM. THE BATHROOM DOOR WAS CRACKED AND A LARGE BLACK FOOT PRINT WAS ON THE OUTSIDE AS DESCRIBED BY THE WIFE CAUSED BY THE HUSBAND KICKING IN THE DOOR.

I THEN ARRESTED BOTH SUBJECTS FOR L.R.S 14:35.3, DOMESTIC BATTERY AND L.R.S 14:37 AGGRAVATED ASSAULT. BOTH SUSPECTS WERE TRANSPORTED TO THE JPCC WHERE THEY WERE RELEASED TO BOOKING WITH NO FURTHER INCIDENT.

ON 04-09-2011 AT 1210 HOURS, JPSO CRIME SCENE TECHNICIAN #1113 TECH KEVIN MURPHY ARRIVED ON SCENE AND PHOTOGRAPHED THE SCENE.
