Dear Administrative Judge Charbonnet,

I am writing to advise you that the Office of Inspector General has referred a matter concerning former Administrative Judge Paul Sens to the Judiciary Commission.

Attachment A lists the names and incomes of eighteen (18) of the former Administrative Judge's family members who work or have worked in the Municipal Court of New Orleans. Relatives of Judge Sens were employed at a collective cost to the City of New Orleans of \$39,000 per month for the period January 2010-to-date; the cost was just over \$1.2 million dollars for this period.

The Commission will take whatever action it deems appropriate. It may find that the hiring and employment of these eighteen (18) family members did not violate applicable ethics codes.<sup>1</sup> But building a family dynasty at the expense of the taxpayers of New Orleans creates an appearance of abuse that undermines public confidence in the judiciary and our elected officials.

*Abuse involves behavior that is deficient or improper when compared with behavior that a prudent person would consider reasonable and necessary business practice given the facts and circumstances. Abuse also includes misuse of authority or position for personal financial interests or those of an immediate or close family member or business associate. Abuse does not necessarily involve fraud, noncompliance with provisions of laws, regulations, contracts, or grant agreements. (Emphasis added).<sup>2</sup>*
