Hi Eric and Matt,

Do you think the following language would be easier to enforce than the language introduced in 29,398 (provided below)?

new language:

At all other times, it shall be unlawful for any peddler or vendor of food to cook, prepare, sell, or vend any food or merchandise from any location where there is a restaurant open for operation within 100 feet of the vendor. The provisions of this subsection will not apply if the vendor displays an express, written waiver of this proximity restriction from the restaurant or restaurants within the 100-feet proximity above.

old language (29,398):

It shall be unlawful for any peddler or vendor of food to cook, prepare, sell, or vend from a trailer, or other mobile temporary facility, or vehicle, or on foot, any food or merchandise within 50 feet of the front door of any lawfully operated restaurant, while the restaurant is open for operation. The provisions of this subsection will not apply if the vendor displays an express, written waiver of this proximity restriction from the restaurant or restaurants within the specified proximity above.
